4	<b>Two recent biometric passport sized photographs (3.5x4,5 cm)</b> <ul style="list-style-type: none"> <li>• Must <b>not</b> be older than 6 months with bright background and frontal view of the face</li> <li>• Digitally altered passport Photos cannot be accepted</li> <li>• Do not glue or staple the photos to the application form</li> </ul>	
5	<b>If fiancé/e in Germany does not hold German citizenship:</b> <ul style="list-style-type: none"> <li>• Two copies of passport and two copies of residence permit</li> </ul>	
6	A <b>written confirmation</b> issued by the competent <b>Registrar’s office</b> in Germany that all necessary requirements for the marriage are met and the intended date for the marriage.	
7	<b>Proof of German language</b> skills at minimum level of A1 in accordance with the European Frame of Reference. Certificates of the Goethe-Institute (not applicable for fiancé/e of a EU citizen other than Germany).	
8	<b>Proof of accommodation in Germany with full address (street, post code)</b>	
9	<b>Proof of fiancé/e’s financial means in Germany (e.g. employment contract, salary slips –not applicable if fiancé/e is a German citizen)</b>
